

# HPCC Systems

## CONTRIBUTION AGREEMENT

\*\*\* Thank you for contributing to the HPCC Systems® software platform! \*\*\*

In order to clarify for both parties the intellectual property license granted with your contributions, HPCC Systems, as maintainer of the Project, desires to have you agree to these provisions regarding your contribution.

Please note, if you developed the source code on behalf of a company or other organization, you must be authorized by that entity to contribute the source code and execute this agreement.

### AGREEMENT

1. **Introduction.** This Contribution Agreement (“Agreement”) between you, either an individual developer or the company identified below (“You”), and LexisNexis Risk Data Management Inc. d/b/a HPCC Systems (“HPCC Systems”) governs Your contribution of copyright-protected source code or documentation (“Source Code”) and any associated patents, trade secrets, and other intellectual property owned or licensed by you that is embedded in or performed by running the Source Code (“IP”). The Source Code and IP together makes a “Contribution”. A Contribution may be sent to HPCC Systems or, when access is provided, added directly to the source code repository. The “Application” means the open source and proprietary versions of HPCC Systems software and their updates, upgrades, and their related services.

2. **License.** You grant HPCC Systems an irrevocable, perpetual, transferrable, worldwide, non-exclusive, royalty-free, sub-licensable license to publicly display, modify, copy, distribute, and use the Source Code in any way related to the Application. You also grant HPCC Systems the right to make, use, sell, offer to sell, import, and distribute the IP in any way related to the Source Code and the Application. The parties agree that they intend these licenses to cover all uses of the Contribution related to the Application by HPCC Systems and the Application’s users and community. To the extent applicable, You will not assert any moral rights related to the Source Code against HPCC Systems or its licensees.

3. **Contribution.** You warrant and represent that You (i) have not received any unresolved legal claims related to the Contribution and (ii) are authorized to grant the licenses identified in Section 2 above (including, if applicable, authorization from your employer) subject to any other agreements and applicable law. If You later receive a legal claim that would require alteration or limitation of the above licenses or these representations, promptly forward a copy to HPCC Systems. If You wish to exclude any portion of contributed source code from the Contribution, You must unambiguously redact such portion prior to sending to HPCC Systems. Unless You expressly decline in writing to be identified, HPCC Systems may list You publicly as a contributor to the HPCC Systems project. HPCC Systems, or any other maintainer of the Application, may decide whether or not to use a Contribution, or any part of it, in its sole discretion.

4. **Disclaimer/Limitations of Liability.** TO THE EXTENT ALLOWABLE BY LAW, YOU PROVIDE THE CONTRIBUTION “AS IS” WITH NO WARRANTIES, EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT. NEITHER YOU NOR HPCC SYSTEMS AND ITS LICENSEES WILL BE LIABLE FOR INCIDENTAL, CONSEQUENTIAL, SPECIAL, EXEMPLARY, OR PUNITIVE DAMAGES (INCLUDING THOSE RELATED TO LOST PROFITS OR LOST DATA) ARISING OUT OF THIS AGREEMENT REGARDLESS OF THE LEGAL THEORY OR CLAIM.

6. **Miscellaneous.** This Agreement constitutes the entire agreement with respect to voluntary contributions from You to HPCC Systems, unless otherwise mutually agreed to between the parties in writing. No amendment or modification of this Agreement will be binding unless written, expressly referencing this Agreement, and mutually signed by the parties. The waiver or failure of either party to exercise in any respect any right provided for in this Agreement shall not be deemed a waiver of any further right under this Agreement. If any provision of this Agreement is deemed invalid, illegal or unenforceable under applicable law, it is to be replaced by a provision that comes closest to the original intent of the parties, and the remainder of the Agreement shall be valid and enforceable to the maximum extent possible. Either party may assign or transfer this Agreement, so long as the assignee or transferee accepts it without modification. This Agreement shall be governed by the laws of the State of Georgia, United States of America, without reference to its conflicts of law provisions and, where applicable, the federal law of the United States. Any dispute arising from this Agreement shall be subject to the exclusive jurisdiction of the state and federal courts located in Fulton County, Georgia. Any judgment or order by any court having proper jurisdiction against a party may be enforced in any court having jurisdiction over such party or its assets. The United Nations Convention on Contracts for the International Sale of Goods does not apply to this Agreement.
